# Bonfils-Stanton Foundation names two new Trustees; awards \$1.5M to Denver arts & cultural organizations

**Denver, CO (February 8, 2022)** – Denver-based funder Bonfils-Stanton Foundation is pleased to announce the appointment of **Dr. Patricia Baca**, who served as the first Latina Deputy Superintendent for Denver Public Schools, and **Rehan K. Hasan, Esq.**, corporate lawyer and business advisor, to its Board of Trustees. Along with new board leadership, the Foundation also awards nearly \$1.5M to Denver arts & cultural organizations.

**Dr. Patricia Baca** joined the Foundation's Board in January 2022. She is a champion of underserved populations and has spent decades advocating for equal opportunities for all, especially children. Dr. Baca has had many firsts – including the first Latina Deputy Superintendent for Denver Public Schools, the District's first Bilingual Teacher and the first Latina Executive Director of Management (Labor) Relations. She served as the first Latina President of the Colorado Association of School Personnel Administrators and the first Latina Personnel Administrator in Jefferson County Public Schools.

In 2018 she was honored as a Trailblazer by the Latinas First Foundation. Dr. Baca graduated with a Bachelor's from University of Denver, Master's from University of Northern Colorado and Doctorate of Education from the University of Houston.

**Rehan K. Hasan Esq.** was elected to the Foundation's Board in January 2022. He is a corporate lawyer and trusted business advisor who assists companies as general outside counsel practicing in all areas of business/corporate law, tax, securities, and financing. Rehan changed the business and tech landscape as an original founder of Galvanize, InCubate (the first US Cuban business incubator in Havana), and Kenzie Academy. He has mentored business owners for years through his work with The Unreasonable Group.

Rehan was named one of the Denver Business Journal's 40 Under 40 and listed on GQ Magazine's Gentlemen's Fund. He has been named a Colorado Super Lawyer since 2015 and received the Exemplary Service Award from the Colorado LGBT Bar Association. Rehan is currently on the board of Curious Theater. And to top it off, he is a trained actor and multi-instrumentalist who is a devoted advocate of arts and culture.

In addition, Bonfils-Stanton Foundation recently approved nearly \$1.5M in arts & culture grants to 28 organizations.
